



## **SHARIA APPROVAL FOR PAYING SADQA & ZAKAT DONATIONS IN BU ZAKAT ENDOWMENT POOL AS SADQA-E-JAARIA FOR EDUCATION OF NEEDY STUDENTS**

### **INTRODUCTION**

1. Zakat is a fundamental pillar of Islam that promotes social justice, compassion and shared responsibility by redistributing wealth to those in need. For needy students of Bahria University, Zakat plays a vital role in ensuring continued access to quality education by helping cover tuition fees, books and basic living expenses. ### **PURPOSE AND UTILIZATION**

- c. Emergency academic assistance for financially distressed students.

**Note: Under no circumstances shall Zakat funds be used for administrative, infrastructural or non-student-related purposes.**

In pursuit of the goal that the entire system is made according to Shariah compliance, the undersigned has been appointed as an independent Shariah Advisor to review all Zakat related documents and procedures. I confirm that Bahria University collects and disburses Zakat funds with due consideration to the ruling and guidance.
